## MINUTES OF THE MEETING HELD ON 26<sup>TH</sup> JULY 2011.

61/7/2011 PRESENT. Cllrs Linnell, Dale, Bunting, Healy, Bennett, Walker were present at the meeting.

62/7/2011 APOLOGIES. There were no apologies for absence.

63/7/2011 ACCEPTANCE OF OFFICE. The declarations of acceptance of office forms were signed.

64/7/2011 ELECTION OF A CHAIR. Cllr Healy was proposed as the Chair of Parwich Parish Council. This was unanimously agreed.

65/7/2011 ELECTION OF THE VICE-CHAIR. Cllr Bunting was proposed as the Vice-chair of Parwich Parish Council and this was unanimously agreed.

66/7/2011 DECLARATIONS OF MEMBER INTEREST. There were no declarations of interest.

67/7/2011 APPROVAL OF THE MINUTES. The minutes of the extraordinary meeting held by the previous Council were not approved or signed. This was because no one at the present meeting attended the extraordinary meeting. The minutes were agreed and signed from the meeting on the 3<sup>rd</sup> May 2011.

## 68/7/2011 FINANCE.

Cllr Healy requested a budget for the next Parish Council meeting. The Clerk advised that the finance and contact details handed over on a CD from the previous Clerk could not be opened. This had created some difficulty.

A sum of £664 in cash was received from Cllr Linnell from the Caravan Club members. The Clerk will bank this money immediately. The Clerk will check, from the previous Clerk, how much the charge is per caravan.

A blank cheque was received from Mr Cooper for the rent of the land. The cheque was sent back to Mr Cooper as it was agreed that he should fill in the cheque amount.

69/7/2011 HIGHWAYS. There were reports of vegetation on the B5056 Ashbourne – Bakewell road. The Clerk is to report this to Highways.

70/7/2011 PARSONS CROFT & PAVILION CLEANING. The Insurance claim is ongoing. The cleaner is to commence her weekly cleaning of the toilets at a cost to the Parish Council of £10 per week. The Tennis Club is to give an invoice to the Parish Council for the cost of creosote to paint the pavilion.

71/7/2011 PLAYGROUND. The Chair is to read the Ropsa report and take responsibility of reporting back to the Parish Council her findings from the report.

72/7/2011 VILLAGE POND. Cllr Walker is to enquire from the PDNPA a suggested planting scheme of this area as it is very bare.

73/7/2011 JUBILEE POND. This looks quite well and is regularly maintained.

74/7/2011 ROYAL WEDDING. Mugs have been handed out to all children under the age of 14.

75/7/2011 MEMORIAL HALL. A representative from the Parish Council is required for the Memorial Hall Committee. Cllr Linnell agreed to fulfil this role.

76/7/2011 FOOTBALL FIELD. The Clerk is to draft a letter of response for the Chair to check and sign.

77/7/2011 TENNIS COURT. This area should be known as the Hard Play Area.

78/7/2011 MEETING DATES. The date of the next meeting will be Thursday 8<sup>th</sup> September. The following dates will be on the 4<sup>th</sup> October and the 1<sup>st</sup> November. Cllr Linnell agreed to display the minutes on the notice board. Minutes are also to be put on the Blog.
